1 CONDUCT A PUBLIC HEARING REGARDING: CHANGES TO WATER LINE EXTENSION COST RECOVERY POLICY.

Mr. Baldwin conducted the public hearing.

3 CONDUCT A PUBLIC HEARING REGARDING: ADJUSTMENTS TO THE CABLE ADVERTISING RATE CARD.

- 4 ACTION ITEM: CONSIDER APPROVAL OF PART-TIME ON-CALL DISPATCHER POSITION.
 - 4.1 The Network Operations Center began operating 24/7 in April of this year and is responsible for regular and after-hours dispatch, customer outage

management, after-hours customer contacts, facility locates, and coordinating emergency response.

In planning for the department, Staff anticipated the need for Part-time On-call Dispatchers to cover employee vacations, leaves of absence, and vacancies. While the department is now fully staffed and there are no anticipated extended absences, Staff would like to prepare now by establishing arrangements with available experienced dispatchers for any future needs.

Staff requests the Board consider approving the Part-time On-call Dispatcher position. If approved, based on FPB policy, the position will not be considered a regular full-time or regular part-time position and is not included in the pay grade classification system. The position is not eligible for FPB benefits including retirement, health insurance, or paid time off.

Staff recommends an hourly wage of \$17.40, which is consistent with the starting pay for the regular fulltime Dispatcher position. Pay above this amount will require the General Manager's approval. The position is not eligible for pay increases except for those approved by the General Manager.

The proposed job description is included in the detail pages for this Board item

Walt Baldwin moved to approve part-time on-call dispatcher position. Jeff Bradshaw seconded the motion. Motion CARRIED. 5 to 0.
